HAC BURGSTALLER GERTIFICATE OF AMENDMENT TO THE BY-LAWS OF THE MEWS CONDOMINIUM AT MUIRFIELD UNIT OWNERS' ASSOCIATION

Dan Danforth, President, and Donna Porterfield, Secretary of The Mews Condominium at Muirfield Unit Owners' Association, an Ohio corporation Not-For Profit, with its principal office located at Dublin. Ohio, do hereby certify that a meeting of the unit owners of said Association entitling them to vote on the proposals to amend the By-Laws of the Association as contained in the following Resolutions, was, duly called, pursuant to notice sent to those unit owners entitled to vote at said meeting, and held on the 12th day of October, 1978, at which meeting a quorum of such unit owners was present in person or by proxy, and that by the affirmative vote of the unit holders entitling them to exercise more than 75% of the voting power of the Association on such proposal the following Resolutions were adopted to amend the By-Laws.

RESOLVED, that Article III, Section 1 of the By-Laws of the Association be, and it hereby is amended to read in its entirety as follows:

Section 1. The annual meeting of the unit owers of this association, for the election of trustees (hereinafter called the Board of Managers or members of the Board of Managers), except as hereinafter provided, the consideration of reports to be laid before such meeting and for the transaction of such other business as may properly come before such meeting, shall, beginning with the year 1979, be held on the second Tuesday in October of each year, or on such other date within one month thereafter as may from time to time be designated by the Board of Managers.

RESOLVED FURTHER, that Article IV, Section 1 of the By-laws of the Association be, and it hereby is amended to read in its entirety

Section 1. Subject to such limitations as are or may be imposed by Chapters 1702 and 5311 of the Revised Code, the Declaration or these By-laws, as any of the same may be lawfully be amended from time to time, all power and authority of this association shall be exercised by a Board of Managers which, until changed in accordance with the provisions of this section, shall consist of five (5) persons. The members of the Board of Managers shall be classified with pospect to the time for which they shall severally classified with respect to the time for which they shall severally hold office, by dividing them into two classes, to be known as

Classes "A" and "B". Without amendment of these By-laws, the number of memebers of any class may be changed by resolution at any annual meeting or at any special meeting called for that purpose. The Board of Managers, none of whom needs to be a unit owner, shall manage and conduct the business and affairs of this association and exercise the powers and duties set forth in said Chapters 1702 and 5311, the Declaration and these By-laws until their successors are elected and qualified. Members of the Board of Managers shall be elected by the unit owners at each annual meeting or at a special meeting called for the purpose of electing them, and such elections may be by ballot or viva voce as the unit owners may determine. Beginning with the annual meeting in 1978, Class A shall consist of two (2) members, each to hold office for one (1) year, or until the next annual election and his successor is elected and Class B shall consist of three (3) members, each to hold office for two (2) years, or until the second annual election and until his successor is elected. At each annual election following the election of the members first chosen by Classes, the successors to the class of members whose terms shall expire in that year shall be elected to hold office for the term of two (2) years, so that the terms of office of one class of members shall expire in each year. Any member of the Board of Managers may resign or may be removed at a special meeting of unit owners called for such purpose by the affirmative vote of those unit owners entitled to exercise not less Classes "A" and "B". Without amendment of these By-laws, the special meeting of unit owners called for such purpose by the affirmative vote of those unit owners entitled to exercise not less than seventy-five percent (75%) of the voting power of all unit
